Privacy Policy

The TimberFever competition (the “**Competition**”) is organised by Moses Structural Engineers Inc. (“Moses”, “us”, “our” or “we”). Information about the Competition can be found on the website located at www.TimberFever.com (the “**Website**”).

This Privacy Policy sets out how we and the other entities who look after the organisation and administration of the Competition collect (collectively, “**TimberFever Organisers**”), use, disclose, store, retain and delete (collectively, “**Handle**”) personal information relating to individuals who wish to participate or who do in fact participate in the Competition. “Personal Information” is information about an individual or associated with an individual, such as an individual’s name, address, age, email address, or phone number.

This Privacy Policy does not apply to aggregated or anonymous information, namely information that is not or ceases to be associated with or linked to you or your Personal Information.

User Consent

When you submit any Personal Information to TimberFever Organisers in conjunction with or in regard to the Competition, you agree to the terms of this Privacy Policy and you expressly consent to the Handling of your Personal Information as outlined in this Privacy Policy. You also consent to receiving electronic communications from us or TimberFever Organisers in regard to the Competition and matters relating thereto, as well as promotional communications about us, TimberFever Organisers and/or Competition sponsors.

Information Collected

We may collect Personal Information that you submit to us voluntarily through our Website, through registration to the Competition or in conjunction with your participation in the Competition, or through communications to or redirected to TimberFever Organisers. The types of information collected in conjunction with the Competition may include, without limitation:

- Name, username, password, mailing address, email address, and contact information.
- University enrollment status, study program, year of studies and university attended.
- Your ideas, views and opinions.
- Other Personal Information you choose to provide such as your preferences, etc.

Use of Information

We may use your Personal Information for the following general purposes:

- To administer the Competition.
- To fulfill or respond to your inquiries.
- To address administrative needs and communications.
- To provide you with newsletters, surveys, promotions, and notices relating to us or other TimberFever Organisers or Competition sponsors, as well as future editions of the Competition and related events.

Information Sharing

Except as otherwise stated in this Privacy Policy, we do not trade, rent, sell or share your Personal Information with third parties. If you provide Personal Information for a certain reason, we may use the Personal Information in connection with the reason for which it was provided. This may entail sharing such Personal Information with contractors and service providers that are providing us with assistance in terms of our operations or with respect to the Competition. This may also include sharing such Personal Information with other members of the Competition team which you are a member of.

Under the following scenarios, we may be required to share your Personal Information:

- If we believe it is necessary to share information in order to investigate, prevent or take action regarding illegal activities, suspected fraud, situations involving possible threats to the physical safety of any person, violations of the Website's Terms of Use, the Competition Rules or as otherwise required by law.
- If we respond to subpoenas, court orders or legal process, or if we need to establish or exercise our legal rights or defend against legal claims.
- If we believe it is necessary to restrict or inhibit any user from using any of our Websites, including, without limitation, by means of "hacking" or defacing any portion thereof.

Opt-Out

You have options regarding the collection, use and sharing of your Personal Information. When you receive promotional communications from us, you may specify a preference to stop receiving further communications from us and you will have the chance to "opt-out" by following the unsubscribe instructions indicated in the communication you receive. Despite your selected preferences, if you are registered to participate in the Competition, we may send you communications regarding the Competition, such as inquiries, administrative updates, reports, and notices.
